To protect the HBANM, its members, and all the Home Show exhibitors, volunteers, vendors, and attendees a General Liability policy of not less than \$500,000 must be in effect from March 11,2026, through March 15,2026. INITIAL Failure to provide the required insurance and corresponding certificate will void this contract and all monies paid will be non-refundable. * **Exception: see rule 11 next page**

MISCELLANEOUS TERMS & CONDITIONS:

- 1) The persons, displays, and promotional material the Exhibitor's display space shall be limited to the business of the Exhibitor. Only one company may exhibit per booth space. Exhibitor promotions must be in the Exhibitor's name and related to the Exhibitor's business. Sub-letting a space is NOT permitted without the approval of the HOME SHOW Chairperson or the Executive Officer of the HBANM.
- 2) **INITIAL** Exhibitor agrees to staff the display space during all show times. Exhibitor is responsible for the delivery, set up, and removal of all displays and display materials and floor coverings. Anything not removed from the convention space by 9 pm on March 14, will be removed by HBANM at the Exhibitor's expense which will include a \$200 service fee.
- 3) Throughout the show the Exhibitor will remove refuse promptly from their display area and deposit it in the designated refuse containers.
- 4) All Exhibits must be designed and operated with a level of decorum and good taste that is representative of the Home Builders Association of Northern Michigan, North Central Michigan College, and the community.
- 5) All laws pertaining to health, fire prevention, and public safety shall be strictly observed.
- 6) Nothing shall be nailed, stapled, duct taped, or otherwise affixed to the curtains, walls, floors, or any part of the exhibition building. Painter's tape is permitted.
